Rental Rate: \$250.00/day **Maintenance Deposit/Cleaning Fee:** \$250.00

Payment shall be due upon signing the rental agreement. Lessee is responsible for returning the No Till Drill in the same condition as it was when picked up. The drills main and small seed boxes and tubes must be fully emptied and cleaned, and the unit greased according to the lubrication schedule in the manual. A charge of \$250.00 will be assessed if the unit is not cleaned and greased per manual guidelines upon return. Rental is at the discretion of the Board of Supervisors. The Coös County Conservation District retains the right to refuse rental for any reason. Rental can ONLY occur if lessee has attended a CCCD offered training for the use of the No Till Drill. If Lessee has NOT participated in a No Till Drill Training, they will NOT be allowed to rent the drill.

Use and Care: Lessee is required to follow all safety and operational procedures as outlined in the User Manual. Lessee is required to read and follow all procedures as outlined in the Material Rate Manual. This No Till Drill is to be used for SEED ONLY, NOT FERTILIZER, there is no fertilizer box. Review of which seed can be used in the main and small seed box and the calibration process can be found in the Material Rate Manual. Lessee is responsible to read this manual and use appropriate seed. A direct link to the Material Rate Manual can be found here:

The Lessee will utilize a tractor with at least 75 horsepower and will ensure the weight of the drill and the amendment will not exceed 1.5 times the weight of the tractor. The Lessee is responsible to maintain the grease schedule and will apply grease for any location as specified in the Operating Manual. A direct link to the manual can be found here:

Additional Terms & Liability: Towing will be allowed if within Coös County NH and Essex County VT with a vehicle equipped for towing. The Lessee will abide by all applicable traffic laws and will never exceed a safe traveling speed. The Lessee will be sure that the lock out pin is in transport position for transporting on roadways. The Lessee will never tow the equipment on limited access highways. Lessee will pay the cost of transporting the Equipment from Lessor’s storage place and returning in thereto. Such transportation shall take place during the term hereof. Lessor is not applicable for transportation costs. If Lessee fails to return the equipment promptly at the end of the term, additional rental fees shall be payable for each day prorated at one and one-half times the normal rate. Lessee is responsible for any damage to the transporting vehicle or the drill itself during transport. Lessee shall indemnify Lessor against all loss or damage to the Equipment while it is out of the Lessors possession. Damage to the equipment shall not abate or excuse making the prescribed rental payments. Lessee agrees to use and care for the Equipment in a careful and prudent manor, to pay all operation maintenance expenses while the Equipment is out of the possession of the Lessor, and to make at his/her expense, any and all repairs. The Equipment shall be returned to Lessor in as good condition as received, reasonable wear and tear expected. If upon its return to Lessor, the Equipment is not in such good condition, Lessor may repair, and Lessee will pay the cost of any such repairs at Lessor’s shop rates. Lessee assumes all risk and liability for and shall defend, indemnify and hold Lessor and its officials, employees and agents harmless from all damages, claims, demands, suits, actions, liabilities and for injuries or death to persons and property arising out of the use, possession or transportation of the Equipment. Lessee at his/her expense will carry insurance applicable to the use of the No Till Drill with minimum general **liability** in the amount of **\$300,000.00** per occurrence for bodily injury and **property** damage. Neither the Lessor, its assigns, the wholesale distributor, nor the Manufacturer shall be liable for any incidental or consequences damages which may result from any failure or use of the Equipment. **The Lessee must provide a Certificate of Insurance that displays these terms and the Certificate must list The Coös County Conservation District as Additional Insured.**
